NOTIFICATION

No. 4-22/2016-ASF In exercise of the powers conferred by sub-rule (2) of rule 3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, the following amendments shall be made in the Recruitment Rules notified vide SRO. 94(KE)/95, dated 17th May, 1995, as amended SRO. 47(KE)/2015, dated 31st October 2013 of Airport Security Forces (ASF) under Aviation Division, namely:-

In the aforesaid Recruitment Rules,-

(i) The "Words", "Brackets" & "Figures" "Assistant Sub-Inspector (BPS-09)", "Sergeant (BPS-07)" & "Corporal (BPS-05)" wherever occurring shall be substituted with "Assistant Sub-Inspector (BPS-11)", "Sergeant (BPS-09)" & "Corporal (BPS-07)"

(ii) Under Rule 2 (Method of Appointment) following proviso shall be inserted:-

Provided that initially the up-graded posts shall be filled in by existing incumbents in the manner prescribed in Establishment Division's d.o. letter No. 8/36/2000-R-I, dated 31-12-2008.

(iii) In schedule (see para 4) against Sl. No. 2, 3 & 4 for appointment to the posts of "Assistant Sub-Inspector (BPS-11)", "Sergeant (BPS-09)" & "Corporal (BPS-07)", under column 3, the following entries at clause (ii) shall be added:-

(ii) After appointment to the post of ASI (BPS-11) candidate has to undergo following 06 weeks training (conducted by ASF Academy):-

a. Aviation Security (Medium Level)

(i) ICAO Standards & Practices / concepts of security

(ii) Manning of key points.

b. Search Methodology (Advance Level)

(i) Personal (ii) Vehicle (iii) Baggage/Luggage

c. Use of Security Equipment


